- In seeking issuance of an Election Sign Permit the Applicant is in agreement to indemnify the Town of any costs incurred relating to Town enforcement to ensure compliance with the provisions of **the Town’s Election Sign By-Law 2028 s. 3.3**
- Upon any violations or failure to comply with the requirements of the Town’s Election Sign By-Law 2028 as determined at the sole discretion of the Clerk, the Clerk reserves the right to retain (in whole or in part) or refund (in whole or in part) the Election Sign Permit Deposit **as per the Town’s Election Sign By-Law 2028 s .3.9**
- The Applicant shall not place or permit to be placed an Election Sign for a municipal election earlier than the day that the Applicant has been nominated or appointed and no earlier than, 45 days prior to voting day in the year of the regular election; or nomination day for a by-election. As per **the Town’s Election Sign By-Law 2028 s. 6.2**
- Every Applicant shall remove all the Applicant’s Election Signs **within 5 business days immediately following 11:59 p.m. of the day of the election as per the Town’s Election Sign By-Law 2028 s. 12.1**
